**Connecticut General Statutes Title 22a, Chapter 4461 Emergency Response Commission** 

- 22a-601 Establishes a CT Emergency Response Commission within the Department of Environmental Protection.
- 22a-602 Requires the Commissioner of Environmental Protection to provide technical and clerical assistance to the Commission.

### Connecticut General Statutes continued

 Authorizes the Commissioner of Environmental Protection to receive, process and manage chemical information and notifications made pursuant to Emergency Planning and Community Right-to-Know Laws.



# **Roles and Responsibilities**

- Appoint Chairperson
- Establish Committee Rules
- Establish procedures for receipt and distribution of chemical information
- Develop, review and update annually Emergency Response Plan

### LEPC Roles and Responsibilities continued

- Publish public notice annually announcing Emergency Plan and chemical information is available
- Evaluate and make recommendation with regard to resources for plan development, maintenance, and implementation.

# Local Emergency Plan Components

- Identification of facilities and transportation routes involving extremely hazardous substances
- On-site and off-site emergency response procedures
- Designation of a community coordinator and facility coordinator to implement the plan

# Local Emergency Plan Components continued

- Methods for determining the occurrence of a release and the probable affected area and population.
- Description of community and industry emergency equipment and facilities and the identify of persons responsible for them.
- Evacuation plans.

# Local Emergency Plan Components continued

- Training programs including schedules for training of local emergency response and medical personnel
- Methods and schedules for exercising emergency response plans

# **Accidental Release Notification**

#### **Section 304 Requirements**

- Unless exempted, a release of an EHS or CERCLA hazardous substance above the reportable quantity must be reported. (If no reportable quantity has been established, the amount will be 1 lb.)
- Immediately report to DEP/SERC, LEPC and NRC (Transportation related incident reporting requirement can be satisfied by calling 911).
- Follow up report must be submitted to the NRC.

# **Connecticut General Statutes 22a-450 Reporting a Spill**

- To report a spill, call 860-424-3338 or Toll Free 1-866-DEP-SPIL (1-866-377-7745)

### Local Fire Marshal Requirement

- Manufacturing establishments must notify the local Fire Marshal of the presence of any hazardous material (Call local Fire Marshal).

# Section 311 and 22a-609 MSDS Reporting Requirements

Unless exempted these requirements apply to:

- Extremely Hazardous Substances (EHS) in quantities greater than the TPQ or 500 lbs
- 10,000 lbs. or more of a hazardous chemical as defined under OSHA

# Section 311 and 22a-609 Submittals

#### Compliance

Facilities must submit a MSDS or a list of chemicals to the SERC, LEPC and local fire department no later than 3 months after a hazardous chemical becomes present at the facility or if there is new information discovered relative to a hazardous chemical.

### Section 312 and 22a-610 Tier II Inventory Reporting Requirements

- If you are subject to the Section 311 reporting requirements, owners or operators must also submit an annual Tier II report which requires an inventory your facility's hazardous chemicals and identification of storage locations.
- The Tier II report form "Tier II Emergency and Hazardous Chemical Inventory" and instructions are available on the U.S. EPA website at yosemite.epa.gov/oswer/ceppoweb.nsf/content/tier 2.htm

### Section 312 and 22a-610 Tier II Inventory Submittals

#### Compliance

- You must submit a completed Tier II report to the SERC, your LEPC, and the fire department who has jurisdiction over the facility each year **by** March 1.
- SERC strongly encourages owners and operators to submit electronic report, known as the Tier2Submit. (Please note: The Tier II report is different than the State Fire Marshal's form.)

# Section 313 and 22a-611 Toxic Release Inventory Reporting Requirements

- Primary purpose is to inform communities and citizens of chemical hazards in their areas.
- The law requires EPA and the states to annually collect data on releases and transfers of certain toxic chemicals from industrial facilities, and make the data available to the public in the Toxics Release Inventory (TRI).

### Section 313 and 22a-611 Toxic Release Reporting Requirements

Manufacturing facilities with Standard Industrial Classification Code 2000-3999 WITH 10 or more full time employees or the equivalent THAT manufacture, process or import more than 25,000 lbs of a toxic chemical listed in 40CFR372.65 otherwise use more than 10,000 lbs listed on the toxic chemical list in 40CFR372.65. For reporting year 2006, facility owners will be using NAICs codes in place of SIC codes.

### Section 313 and 22a-611 Toxic Release Inventory Submittals

#### Compliance

EPA has TRI-ME software to assist the users. The CD-Rom with the *TRI-ME* software is available to download from

www.epa.gov/tri/report/trime/index.htm.

 Report must be must be submitted every July 1 to the CT SERC and Federal EPA in Washington, D.C.
