

Agenda of Regular Meeting

(April 3, 2013)

A regular meeting of the Public Utilities Regulatory Authority (Authority) and/or staff members of the PURA will be held in the offices of the Authority, Ten Franklin Square, New Britain, Connecticut, on Wednesday, April 3, 2013, at 9:30 a.m. concerning the following:

1. Consideration of the following Draft Decisions:

Docket No. 12-11-06 - Application of P. Titov and S. Palle for a Variance to Section 16-11-64 of the Regulations of Connecticut State Agencies for Water Service Located at 21A and 21B Christiano Street, Cos Cob, Connecticut (Aquarion Water Company) (CBH);

Docket No. 13-01-13 - Application of Kenwind Industries Ltd. for Qualification of LeNordais Wind Farm as a Class I Renewable Energy Source (CBH);

Docket No. 13-01-17 - Application of Birch Communications, Inc. for a Telcom CPCN (CBH); and

Docket No. 13-01-24 - Application of Ilene Wolf for a Public, Educational and Governmental Programming and Education Technology Investment Account (PEGPETIA) Grant (CHB).

Administrative matters, (e.g. – assignment of panels of Directors for new cases; various personnel and staffing issues; briefings regarding the doings of the National Association of Regulatory Utility Directors and its subcommittees, the New England Conference of Public Utility Commissioners, the New England Independent System Operator and other federal agencies; and any other matters regarding the administration of the Authority.)
6. New business.
