**III. NEW BUSINESS**

A. Proposed Memorandum of Decision  
Sushil Gupta, MD – Petition Nos. 2013-416

Attorney James Biondi was present with respondent. Attorney David Tilles was present on behalf of the Department of Public Health.

Argument was heard from Attorney Biondi and Attorney Tilles regarding the proposed of petitioner's license. Hearing panelists Dr. Hodgson and Ms. Emmett spoke in favor of reinstatement; Dr. Gordon spoke in opposition.

Dr. Sadinsky made a motion, seconded by Dr. Green, to adopt the proposed decision with the addition of language regarding the successful completion of the SPEX examination and technical changes.

The motion passed with Ms. Emmett, Dr. Hodgson, Dr. Wolf, Dr. Green, Ms. Loving, Dr. Sadinsky, Rabbi Greer, Dr. Zeman, Dr. Duffy and Dr. Monico in favor.

Dr. Gordon, Ms. Collins, Ms. Doremus, Mr. Andrews and Dr. Fellows were opposed.

B Request for continuance of hearing  
Prem Nath, MD - Petition No. 2009-20091373

Assistant Attorney General Daniel Shapiro was present to provide counsel to the Board.

The Board reviewed a request from respondent for a continuance of a hearing scheduled for December 6, 2013 due to an ongoing medical condition which makes him unable to participate in the hearing. Attorney Shapiro advised the Board that it was the advice of the Assistant Attorney General to grant the request.

Dr. Green made a motion, seconded by Dr. Fellows, that the request be granted. The motion passed unanimously.

**IV. OFFICE OF LICENSURE REGULATION AND COMPLIANCE**

A. Douglas Wisch, MD – Petition No. 2013-582

Principal Attorney Matthew Antonetti, Department of Public Health presented a Consent Order in this matter. Respondent was represented by Attorney Richard Tynan.

Ms. Collins made a motion, seconded by Ms. Loving, to adopt the Consent Order. The motion passed with all in favor except Dr. Green who recused himself. Ms. Emmett signed the Order which imposed a \$5000.00 civil penalty.

Dr. Gordon made a motion, seconded by Dr. Fellows, to grant a 120 day extension in this matter. The motion passed unanimously.
