August 13, 2024, Primary: Key Early Voting Deadlines and Dates

The table below provides key deadlines and dates for early voting before the August 13, 2024, primary. Since same-day registration (SDR) is available only before regular general elections, the table does not include any deadlines or dates associated with early voting.

Please note: The deadlines for submitting and reviewing early voting plans have been changed in accordance with PA 24-148 (Sec. 25).
