The head moderator shall also seal and deliver an original head moderator's return to the Secretary of the State not later than the third day after the election.

The head moderator in each town shall deliver to town clerk one copy of duplicate certificate of votes cast for candidates not later than forty-eight hours after the close of the polls. Use additional pages, if necessary.
