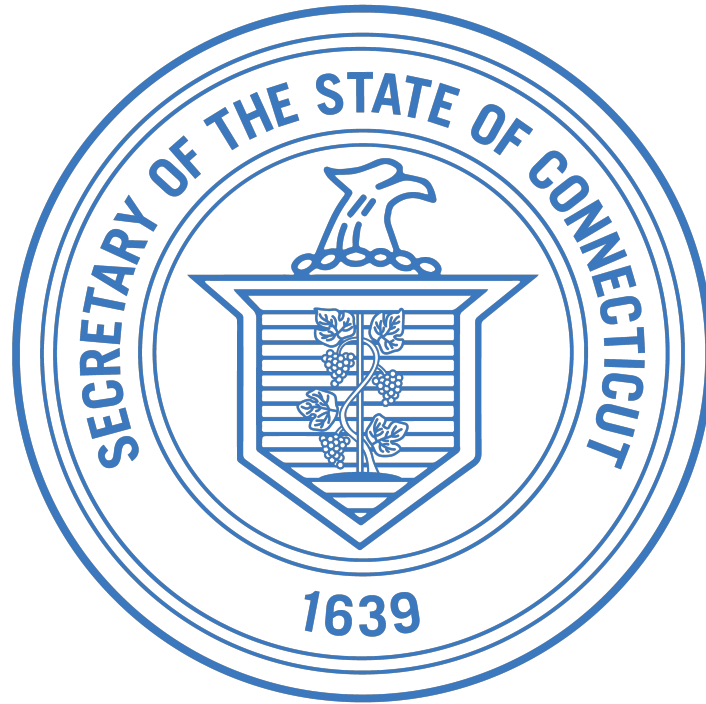

# 01. Election Day Fast Facts

## Relevant Dates and Deadlines:

### Friday, October 4, 2024

- Absentee Ballots are available to be mailed to electors with an approved absentee ballot application (you may submit your absentee ballot application at any time)

### Friday, October 18, 2024 8 am - 8 pm

- Deadline for:
  - **Mail-In** Voter Registration Applications to be Received or Post-Marked by this day to the Registrars
  - **Online** Voter Registration **by 11:59 pm**
  - Voter Registration **at the DMV** by the close of business
  - **In-Person** Registration with your Registrar of Voters **by 8 pm**

### Monday, October 21, 2024 - Sunday, November 3, 2024

- Early Voting Period (10 am - 6 pm every day, except October 29 and 31, when hours are 8 am - 8 pm)
- Same Day Registration (SDR) is available to all eligible voters

### Wednesday, October 30, 2024

- Emergency Absentee Ballots first available for request for those who suddenly fall ill, face an unforeseen physical disability, or are in a hospital or nursing home during this period

### Monday, November 4, 2024

- By close of Town Clerk's office: deadline for in-person absentee ballot submission to Town Clerk by applicant

### Tuesday, November 5, 2024: Election Day

- 6 am - 8 pm: Polls Open
- By 8 pm: Completed Absentee Ballots must be received by Town Clerk via **Mail**, via **Official Drop-Box**, or **In-Person** (by an [immediate family member](#) of the applicant or by a [qualified designee](#) of an ill or physically disabled ballot applicant)
- Same Day Registration (SDR) is available to all eligible voters

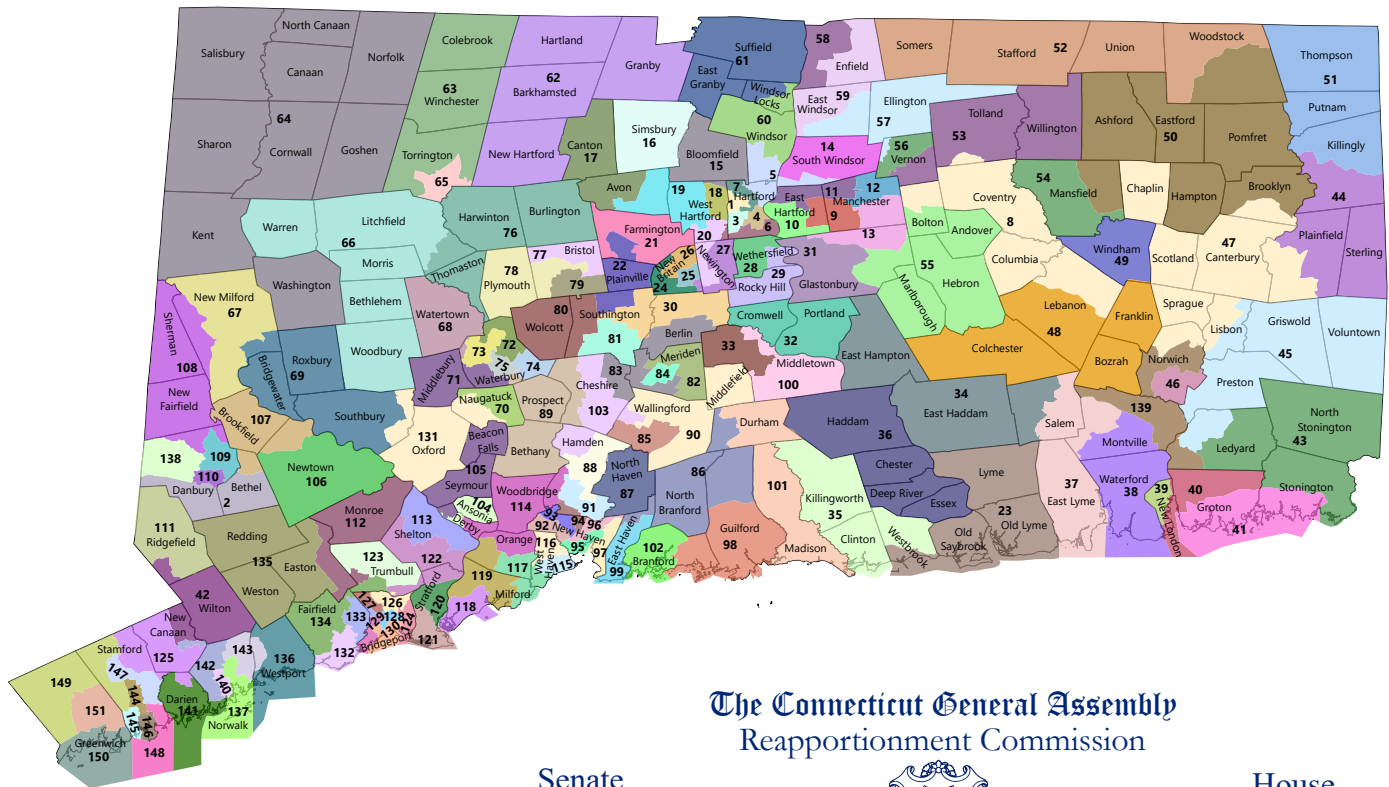

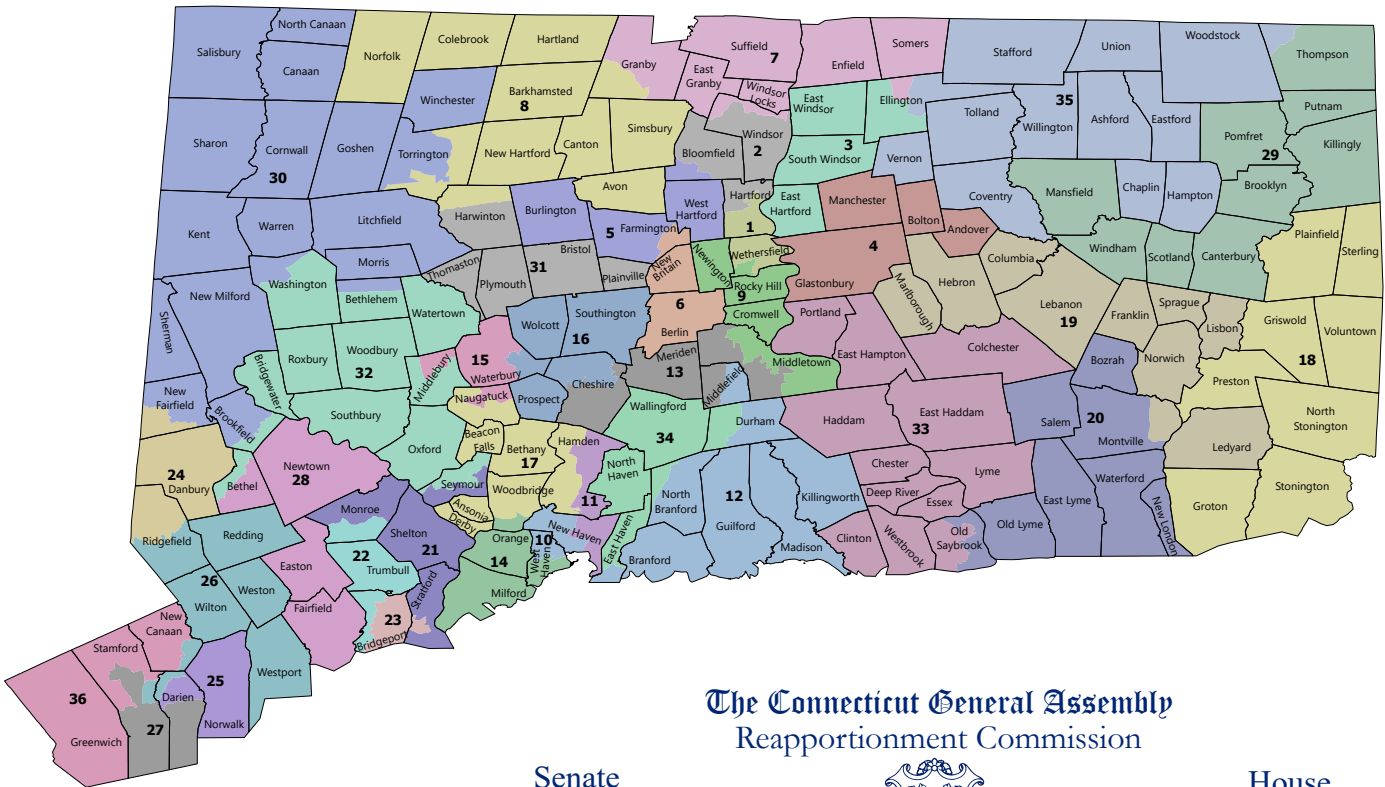

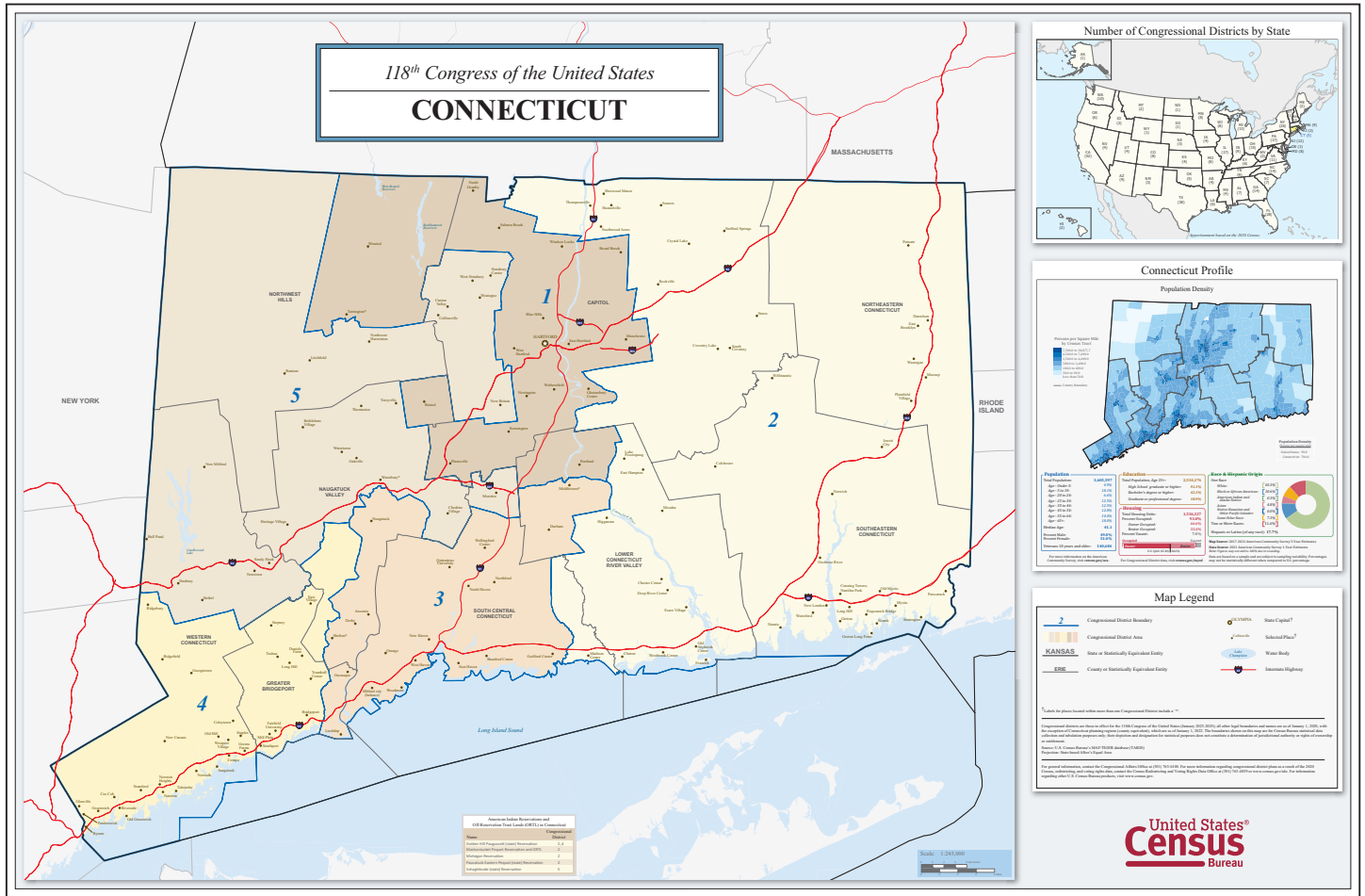

## 03. Who Can Register to Vote?

You are eligible to vote in Connecticut IF you:

Are a US citizen living  
in Connecticut

Are 18 years old, or turning  
18 before Election Day

Have completed  
confinement, if you  
were convicted of a felony

Designated Voter Registration Agencies (such as armed forces recruitment offices, public libraries, public universities/colleges, and other public assistance offices) that are required to have voter registration forms available

\* You are not a voter until your application is approved by the Registrar of Voters. You should receive a confirmation within 3 weeks. If you do not, contact the Registrar in your town.

## 04. Voter ID Requirements

Connecticut requires voters to present an acceptable form of ID, but not photo ID, either when they register to vote or when they vote in a primary, election, or referendum. The requirement to present ID when voting depends on whether the voter presented ID when registering to vote. For additional information, visit [FAQ - Voter Identification \(ct.gov\)](#)

All other voters (this includes most voters)	Social security card  or  Any pre-printed form of ID showing the voter’s name together with his or her (1) address, (2) signature, or (3) photograph	Form ED-681

A drive-only license is not valid for federal identification purposes and cannot be used to vote.

Provisional Ballot - Election officials issue provisional ballots under certain circumstances and only when a candidate for federal office is on the ballot. Provisional ballots do not include candidates for state or local elections. To vote by provisional ballot, people must fill out an application under penalty of false statement attesting to their eligibility and current standing as an elector in the town where the polling place is located. Registrars have six days after a primary or general election to authenticate the information on each provisional ballot. The ballots are kept separate and counted only after the registrars verify eligibility.

Form ED-681 - Voters sign this form, entitled “Signatures of Electors Who Did Not Present ID,” under penalty of false statement to attest to their identity (CGS § 9-261(a)). By law, false statement is a class A misdemeanor, punishable by up to one year in prison, a fine of up to \$2,000, or both (CGS § 53a-157b).

## 05. Same Day Registration (SDR)

SDR allows any eligible CT voter, who is not yet registered or is registered in one town but has moved to another, to register and subsequently vote on an Election Day.

- Register at your town's designated SDR location during any of the 14 Early Voting Days.
- At least one SDR location will be designated in each town where you may register and vote during the Early Voting period or on Election Day.
- In most towns, the SDR location will be the same as the Early Voting location.

Note: Early Voting locations may change from election to election. To confirm the correct location, please check your town's website or [MyVote.CT.gov](https://www.MyVote.CT.gov) four weeks prior to the election.



## 06. What Are Your Rights as a Voter?

Every registered voter in the state of Connecticut has the right to:

**1. Inspect a sample ballot prior to voting.**

- At your polling place, you can access a sample ballot by asking the moderator to provide you with one, or find one online on the CT Secretary of the State's website.

**2. Receive instructions on how to operate the equipment used to vote.**

- Similar to a sample ballot, the moderator at your polling place can also provide guidance on how to use the voting equipment.

**3. Cast a ballot if you are still in line when the polls close.**

**4. Ask for and receive assistance in voting, including assistance in a preferred language other than English. Contact your Registrar of Voters in advance to confirm availability of translation services.**

**5. Vote free from coercion and/or intimidation from election officials or any other person.**

**6. Cast a ballot using voting equipment that accurately counts all votes.**

**7. Vote by provisional ballot if you registered to vote but your name is not on the voter list.**

- You may apply for and cast a provisional ballot upon the execution of a written affirmation at the polling place affirming that you are qualified to vote in the election or primary for federal office in the polling place; and you have neither offered yourself to vote nor voted in person or by absentee ballot at said election or primary for federal office at the polling place.

**8. Be informed of the process for voting if formerly incarcerated.**

**9. Vote independently and in privacy at a polling place, regardless of physical ability or disability.**

If any of your rights have been violated, you have the right to file an official complaint with the [State Elections Enforcement Commission](#) by calling **1-866-733-2463** or **online**, or with the United States Department of Justice at **1-800-253-3931**. In addition, before leaving the polling place you may notify the moderator of the violation. If you believe your voting rights have been violated based on discrimination against your protected class, you can [contact your local CHRO office](#) to file a complaint of discrimination.

# 07. Three Ways to Vote in Connecticut

## In-Person Early Voting:

2024 is the first year that Connecticut is offering an Early Voting option. Each town will have at least one EV location, allowing voters to cast their vote from 10am to 6pm on any day between Monday, October 21st and Sunday, November 3rd.

\* **Note: On October 29th and October 31st, Early Voting centers will be open longer, from 8 am to 8 pm**



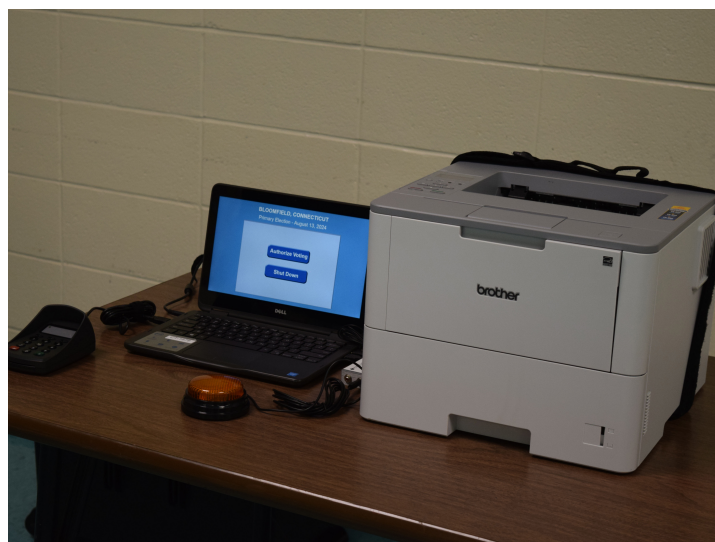
## Absentee Voting:

Connecticut law allows an individual to apply to vote by absentee ballot if they are unable to appear at their polling place on Election Day for one of the following reasons:

- Active service in the armed forces
- Absence from town on Election Day
- Sickness (not necessarily your own)
- Physical disability (not necessarily your own)
- Religious beliefs which prevent secular activities like voting on Election Day
- Duties as an elections official in a town other than one's own

## In-Person Election Day Voting:

## 08. All About In-Person Early Voting

### 1. What is Early Voting?

Early Voting allows voters to vote in-person safely and securely before Election Day.

### 2. What should voters expect at the Early Voting location?

When voters arrive at the Early Voting location, they will check in and be verified as an eligible voter. They will then receive a ballot with an envelope. They will complete their ballot at a privacy booth and seal it in the approved envelope. Before leaving, they will place the sealed envelope in the secure receptacle as instructed by the election officials. Ballots will be secured unopened until Election Day.

### 3. When will ballots be counted?

Ballots cast during Early Voting will be sealed and stored securely in each town. They will be opened and counted on Election Day.

### 4. How does Early Voting differ from absentee voting?

Absentee ballot voting requires a reason (see “Three Ways to Vote in Connecticut” earlier in this guide). Early Voting is available to every eligible voter, without a specific reason needed. Early Voting may be done only in-person, not via mail or drop box.

### 5. How many Early Voting locations will be in each city/town?

Each town/city will have at least one Early Voting location. If the population is 20,000 or more, the local legislative body will decide whether to have additional locations. Voters can check their municipality’s website for its Early Voting location or visit [MyVote.CT.gov](https://www.ct.gov/MyVote) approximately one month before the election for the location.

### 6. Can I vote on weekends?

Yes. Early Voting includes Saturdays and Sundays. See #10 for specific election dates.

### 7. How is it ensured that people do not vote twice?

The election official at each Early Voting location will record that a voter has cast their ballot, preventing that voter from voting early at any other location, submitting an absentee ballot, or voting on Election Day.

### 8. Does Early Voting exist in other states?

Although new to us this year, Connecticut became the 47th state in the country to offer some form of Early Voting.

### 9. What hasn't changed?

Voters can still vote via absentee ballot or on Election Day as usual. Election Day hours remain the same, 6 am - 8 pm.

### 10. When is the Early Voting period?

EV period lasts from Monday, October 21, 2024 to Sunday, November 3, 2024 from 10 am - 6 pm each day (except for October 29 and 31, when Early Voting locations are open from 8 am - 8 pm).

### 11. Where is my town's Early Voting location?

Check the [Secretary of the State website](#) or your municipality's website approximately one month prior to the election to find your Early Voting location(s).

### 12. Why should I choose Early Voting?

Early Voting may be the right option for you if you are unsure of your availability on Election Day. Advocates have cited reasons such as unreliable transportation, inconsistent health, uncertain work schedules, parenting or caregiving, poor weather for nervous drivers, or qualified absentee ballot users who prefer to vote in person as just a few of the reasons a voter might chose this option.

## 09. All About Election Day Voting

- Tuesday, November 5, 2024 from 6 am - 8 pm
- What to Expect
  - Arrive and be verified as an eligible voter
  - Receive your ballot and mark it at a booth (or use an accessible IVS machine)
  - Place your completed ballot into the tabulator
  - Collect your "I Voted" sticker! Congrats!
- Tips for filling out a ballot:
  - Fill in the oval entirely
  - If there is an office you do not want to vote for, leave it blank
  - Be sure to check both sides of the ballot
- What if I make a mistake on my ballot?
  - Return it to the Ballot Clerk to void it and receive a new one. Ballots – marked or unmarked—should never be left in the privacy booth, thrown away, or removed from the voting location.



# 10. All About Absentee Voting

Absentee voting is a two-step process:

1. Applying for a ballot
2. Receiving and returning the ballot

## Applying for a ballot

You are eligible to vote absentee if one of the below reasons would prevent you from appearing at the polling place on Election Day:

You are an active member of the United States Armed Forces

You will be out of town for some or all of Election Day

Sickness (not necessarily your own) prevents you from voting in-person on Election Day

The tenets of your religion forbid secular activity on the day of such election

Physical disability (not necessarily your own) prevents you from voting in-person on Election Day

You will be performing duties as an election official at a polling place other than your own

## Three Ways to Apply for an Absentee Ballot:

### Option 1:

Visit the Secretary of the State's [online portal](#) for absentee voting

### Option 2:

Download an [application in English](#) or an [application in Spanish](#), fill it out, and return it to your Town Clerk

### Option 3:

Go to your Town Clerk's office!

If you need an emergency ballot within 6 days of election due to an unexpected medical situation, download an [emergency application in English](#) or an [emergency application in Spanish](#) from the Secretary of the State's website

- Emergency Ballots are available **only** for those who experience an unforeseen illness or physical disability within these 6 days, or because they are patients in a hospital or residents of a nursing home within such period.

## Can I request an absentee ballot application for someone other than myself?

- For Immediate Family: Yes! You can request an absentee ballot application for any of your immediate family (parents, children, siblings, spouse), or any other dependent relative who lives in your household
- For Circulators: If you would like to obtain five (5) or more applications for individuals other than immediate family members, you must register with and obtain forms from the Town Clerk, as well as file a list of names/addresses for absentee ballot applicants with the Clerk prior to the election.

## Returning Absentee Ballots

### 1. Who can submit absentee ballots?

#### **If Mailing or Depositing in Drop Box:**

If you are submitting your absentee ballot through mail or drop box, it can be submitted by (1) you (the voter), (2) the immediate family of a student voter, or (3) a designee of a voter who is requesting to vote absentee due to illness or disability

- **What is a designee?**

Someone who is caring for a voter with an illness or disability (such as a nurse), a member of the voter's family (who is designated through a former filing of Section VII, "Declaration of the person providing assistance"), or a police officer/Registrar of Voters, Deputy Registrar of voters, or Assistant Registrar of Voters in the municipality

#### **If Returning in Person to Town Clerk:**

If you are submitting your absentee ballot in person, it can be submitted by (1) you (the voter), (2) an immediate family member of the voter, or (3) a designee of a voter who is ill or physically disabled (before polls close on Election Day)

### 2. When do I need to submit the absentee ballot by?

- **In Person by Voter to Town Clerk:** 1 day before Election Day, before closing
- **In-Person by Designee of Ill or Disabled Voter to Town Clerk:** Election Day, 8 pm
- **By Mail & Drop Box:** Received by Election Day, 8 pm

### 3. FAQs about Absentee Ballots

**Q1**

What protections are in place to safeguard against ballot stuffing?

- ▶ When an applicant for an absentee ballot is approved, their information is entered into the Central Voter Registration System. Checkers at polling places will be able to see that an absentee ballot was sent to the individual if an attempt to vote in-person is made. Also, after polls have closed on Election Day, received absentee ballots are compared to the official Election Day checklist.

**Q2**

What if I applied, but don't receive my ballot?

- ▶ If you did not provide a telephone number or email on your application, the Town Clerk would have no way to contact you about an issue. Contact your Town Clerks office if you haven't received your ballot after they have become available. If this occurs within one week of the election, due to mail delivery times, it is recommended that you vote by absentee in-person at your Town Clerk's office or use Early Voting or Election Day voting to cast your ballot.

**Q3** What if someone offers to turn my ballot in for me?

- ▶ The **ONLY** people who can turn your ballot in are you, an immediate family member, or an official designee. Anyone else is in violation of Connecticut law.

**Q4** What if I don't fit the requirements for an absentee voter but I still want to vote absentee?

- ▶ Under current Connecticut law, you must meet one of the eligibility requirements.

**Q5** Is there a permanent absentee ballot list?

- ▶ Applying for an absentee ballot is an election-by-election process for most voters. You may apply for a permanent absentee ballot only if you have a permanent disability. Contact your Town Clerk for details.

## 11. Tips for Overseas and Military Voters

1. Military and overseas voters can request an [absentee ballot using the State of Connecticut's application](#), or a Federal Post Card Application (FPCA)
  - Assistance with a FPCA can be found through the Federal Voting Assistance Program ([FVAP](#))
2. Either application can be delivered by mail or electronically to the municipal clerk in the Connecticut town where you are registered, assuming a valid e-mail is provided on the application
  - Find your municipal clerk on your town's website or the [Secretary of the State's website](#)
3. If a regular absentee ballot will not be received in time, active armed service members, members of the merchant marines, and their spouses or dependents can submit a Federal Write-In Absentee Ballot ([FWAB](#)) for the federal offices up for election
  - The FWAB must be received by your local CT voting officials before polls close on Election Day
4. Once your completed absentee ballot has been returned to your municipal clerk, its status can be tracked online, on the Secretary of the State's [voter registration lookup](#) web page.

## 12. Voting if Currently or Previously Incarcerated

A person **loses** their right to vote in Connecticut if they have been convicted of a felony **and** are currently incarcerated in a correctional facility. You **do not** lose your right to vote if convicted and incarcerated for a misdemeanor or if in pretrial detention.

### Voting if currently incarcerated:

1. Must be at least 18 years of age by the next election and a U.S. citizen, in addition to the criteria listed below
  - Not currently incarcerated for a current **felony** conviction
    - You can also vote if incarcerated for a misdemeanor
    - You can also vote if you have an unsentenced status with no prior felony conviction (unless voting rights have been restored following the release from incarceration for the felony conviction)
    - You can also vote if you have a previous felony conviction and had your voting rights restored, but are currently incarcerated on a separate, non-felony conviction

Your Unit Counselor or facility's Re-Entry Counselor can give you the address of your Registrar of Voters and Town Clerk's offices. You can correspond with these offices for the purposes of voter registration and voting in the next election.

### Voting if previously incarcerated:

1. If **not** convicted of a felony, you retain your right to vote in Connecticut
2. If you were convicted of a felony, you can restore your voting rights in Connecticut **upon release from incarceration**
  - However, if the felony offense is for violating Connecticut election laws, you must then complete your probation and/or parole before becoming re-eligible to vote.

### Process for Restoring Voting Rights (or to register for the first time):

1. Fill out a voter registration form and submit it to the Registrars of Voters in the town where you live **in-person**  
or **by mail**, or
2. Register online with a valid CT driver's license or non-driver ID at [MyVote.CT.gov/register](https://MyVote.CT.gov/register), or
3. Register at the DMV when you apply for a CT license or non-driver ID, or
4. Obtain a voter registration form from your Registrar of Voters, any public library, the Department of Social Services, or any other voter registration agency

\*Upon registration, you will receive confirmation in the mail within three weeks. If not, contact the Registrars of Voters in your town.

## 13. What to Expect for College Students

- ▶ College students may choose to vote in their hometown or in their college town whether it is in Connecticut or out-of-state
  - If you are a commuter, register in the town where you live
  - If your hometown is in Connecticut and your college is in Connecticut, register in the town in the state where you would like to vote
  - If your hometown is out-of-state and your college is in Connecticut, register in the town in the state where you would like to vote
  - If your hometown is in Connecticut and your college is out of state, register in the town in the state where you would like to vote (note: other states may have residency requirements)
  
- ▶ You must be registered to vote in the town where you plan to vote.
  - If you attend college out-of-state and want to vote in that state, contact the local election office in that state for the proper procedures
  - In order to vote in Connecticut, you must be registered to vote in the appropriate town in Connecticut; if you are already registered, you may need to change your address if you will vote in a town different than where you are registered
  - Registering to vote is simple and may be done
    - Online if you have a Connecticut driver's license
    - By Mail
    - In person with your Registrar of Voters
    - In person via same day registration during the Early Voting period or on Election Day
    - At DMV and other voter registration agencies
  - See sections 3 and 5 for additional information about registration
  
- ▶ If you are voting in Connecticut, decide how you will vote
  - In person during Early Voting (additional details in section 9)
  - In person on Election Day (additional details in section 10)
  - If eligible, by absentee ballot (additional details in section 11)
    - Allow enough time to submit your application, receive your ballot, and return it
  
- ▶ If you are a U.S. citizen and Connecticut student studying or serving abroad, you may still vote while living outside of the United States (additional details in section 11)

# 14. Election Laws

## State Elections Enforcement Commission

The Commission's statutory responsibility is to enforce provisions of state election laws pertaining to elections, primaries and referenda, and the campaign finance there of.

# 15. Voting Accessibility Options

## 1. Trouble Filling Out a Voter Registration Form

- Another individual can ask the applicant if they need assistance writing down answers
  - If so, the person writing must actively ask the applicant for each answer and cannot give any answers for them
  - The applicant must be the one to fill out their SSN and signature. If they cannot write or have difficulty, they can put an “X” for the signature
- Online registration on the Secretary of the State’s website is compatible with most text to speech programs
- The applicant may visit their Registrar’s office to fill out their registration

## 2. Voter registration applicant is houseless and does not have permanent address

- They may list anywhere they receive mail or where they spend most of their time, including libraries, shelters, jobs, or streetcorners

## 3. IVS Machine

- The Integrated Voting Systems (IVS) ballot marking device is an accessible alternative to pen and paper ballots at all polling places and Early Voting locations
- Voters with low vision, physical, sensory, or other disabilities, as well as any voter who prefers it, may use this option
- Choices can be made audibly or with a touchscreen that includes tactile keys and customizable displays
- The voting experience does not otherwise change

## 4. Curbside voting

- If you arrive at the polling place but are unable to access it due to a temporary incapacity, you may request that a ballot be brought to you.
- The Registrars of Voters, or their assistants, from both parties, will bring the individual a ballot and a privacy sleeve
- After showing the proper identification, the voter must mark the ballot in front of the officials but not in a manner that violates their right to privacy
- The election officials will return the ballot in the privacy sleeve to the Early Voting ballot box or Election Day tabulator

## 5. Difficulty standing in line

Alert the Moderator of the Early Voting location or polling place and they will move you to the front of the line or arrange to hold your place in line while providing you suitable seating

## 6. Signage about ballot questions

- On Election Day, each polling place will have at least 3 posters explaining the proposed constitutional amendment

## 16. Language Assistance

1. Spanish language forms and options are available on the Secretary of the State's website, including for absentee ballot applications, voter registration forms, sample ballots, and more
2. The federal and state voting rights acts require language assistance in voting and elections in municipalities with a significant and substantial need in accordance with data. For additional information on qualifying towns, visit the [language assistance page](#) on our website.
3. Municipalities may offer voters access to translation in hundreds of languages via a live translator on a laptop, tablet, or mobile device. Contact your Registrar of Voters to determine if this service is available at your EV location or polling place
4. Please consider applying to be a poll worker if you have fluency in foreign language to help create more accessible voting for all!

## 17. Sample Ballots

Voters may familiarize themselves with what will appear on their ballot before going to polls by viewing sample ballots on the Secretary of the State's website.

- Include all candidates for office in your district
- Include any ballot questions
- Are provided in all languages required by the federal or state voting rights acts
