

Secretary of the State of Connecticut September 9, 2025, Primary: Key Early Voting Dates and Deadlines

The table below provides key dates or deadlines for Early Voting before the September 9, 2025, Primary.

Deadline for Registrar to Finalize Early Voting Plan	Location(s) must be finalized 31 days before the Primary	Finalization deadline: August 9, 2025
Deadline for Reporting Additional (Optional) Early Voting Location(s) for a Municipality with a Population of 20,000 or more	The legislative body in municipalities meeting the population threshold must determine whether to designate additional location(s). The legislative body may make this determination either (1) after holding a public hearing, or (2) on its own. The legislative body must then report this information to the Secretary of the State, who retains it as a public record.	Public hearing notice deadline: June 16, 2025 Public hearing deadline: June 26, 2025 Deadline for reporting information to the Secretary of the State: If the legislative body holds a public hearing, three days after holding it. If the legislative body does not hold a public hearing, by June 29, 2025.

Deadline for Town Clerk to Publish Notice of the Primary	Forthwith after receiving notice from the Secretary of the State or registrars of voters, as applicable, that a primary will occur	Secretary of the State sends notice of primary to town clerks and sends list of offices: August 6 , 2025 Deadline to notice primary: forthwith after receiving notice from the Secretary of the State that a primary will occur
Deadline for Unaffiliated Voters to Enroll and Vote Early	12:00 p.m. on the business day before the early voting period begins	Enrollment deadline: August 29, 2025
