Box 150470, Hartford, CT 06115-0470 <u>not later than 6:00 p.m. of the day after the election</u>, or to the <u>State Police not later than 4:00 p.m. of the day after the election</u> and to deliver the <u>other set</u> to the <u>Town Clerk</u>.
