PRESCRIBED FORM FOR RETURN OF VOTES CAST AT A MUNICIPAL ELECTION
(C.G.S. §.9-314(b))

ONE SET of return forms is enclosed. After all entries have been completed and proofread and any corrections made, the **complete set of returns should be photocopied** and both sets signed in the original by the Head Moderator, or moderator in municipalities with only a single voting district, at each place indicated and **deliver one set** of such returns either (1) by fax to the Secretary of State by 12:00 midnight on Election Day at 866-392-4023 and then deliver such return to the **Secretary of State**, not later than the third day after the election or (2) by hand delivery to the **Secretary of State**, Legislation & Elections Administration Division, 30 Trinity Street, P.O. Box 150470, Hartford CT 05114-0470 not later than 6:00 p.m. of the day after the election or to the **State Police** not later than 4:00 p.m. of the day after the election, and deliver the **other set to the Town Clerk**. Use additional pages if necessary.
