WHO MAY USE THIS FORM: Because of the federal Voting Rights Act of 1965, as amended and Connecticut implementing legislation, certain persons, described below, will be eligible to vote for candidates for electors of President and Vice President in the presidential election, but for no other candidate.

Any former resident wishing to vote in that election may do so only by means of paper "Presidential Ballot." You may obtain such a ballot by filing this application with the appropriate Town Clerk.

FORMER RESIDENT: a. You were formerly a resident of the town to which you are directing this application and b. you have moved to your present residence in another state with in thirty days prior to the date of the presidential election and for that reason are prevented from registering to vote in the town of your present residence.

NOTE: Any elector (registered voter) who expects to be absent from the town during all hours of voting is entitled to use the regular absentee ballot containing all officers to be voted on. In such case, application should be made on the form entitled "Application for Absentee Ballot" which may be obtained from your Town Clerk.
