- Party designation** shall consist of not more than three words and not more than twenty-five letters; shall not incorporate the name of any major party; shall not incorporate the name of any minor party which is entitled to nominate candidates for any office which will appear on the same ballot with any office included in this statement; shall not be the same as any party designation for which a reservation with the Secretary of the State is currently in effect for any office included in this statement; and shall not be the word "none", or incorporate the words "unaffiliated" or "unenrolled" or any similar negative form of the words "affiliated" or "enrolled".
- This statement shall not include an office unless at least one elector signing this application is entitled to vote at an election for such office.
- At least twenty-five (25) electors must sign this application (see reverse side) as members of the Party Designation Committee.
