SECRETARY MERRILL DRAWS PRECINCTS TO HAVE NOVEMBER 6TH PRESIDENTIAL ELECTION RESULTS AUDITED

10% of All Voting Precincts Using Optical Scanners Will Have Ballots Hand Counted and Matched Against Machine Totals to Ensure Integrity Of Voting; Merrill Still Missing Voter Turnout Statistics from 13 Cities and Towns

Hartford: Secretary of the State Denise Merrill today announced the 75 voting precincts that will have election results audited following the November 6, 2012 presidential election. The voting precincts were randomly selected with Connecticut Voting Rights advocates at a news conference at the State Capitol yesterday. As required by Connecticut General Statutes 9-320f, ten percent of the polling precincts in the election using optical scan voting machines are subject to an audit. All told, 747 polling precincts used optical scan voting machines on November 6th, meaning that some 75 precincts were chosen to have their election results audited. Secretary Merrill is also asking all Connecticut cities and towns to report voter turnout statistics to the Secretary of the State's office as required by state law. As of today, November 20, 2012, some two weeks after the election, the following municipalities have still not reported the number of registered voters to cast ballots on Election Day: Chaplin, Chester, Hartford, Meriden, Middlefield, North Canaan, Preston, Prospect, Sherman, Stratford, Washington, Winchester, and Windham.

"We had a remarkably smooth Presidential election on November 6th, especially given our state of recovery from Hurricane Sandy," said Secretary Merrill, Connecticut's chief elections official. "Now, it is our duty to audit the machine totals from the election to ensure the accuracy of our optical scanners. We are committed to making sure Connecticut voters have continued confidence that their votes were recorded accurately and that's why these independent audits are so vital. I also implore the cities and towns who have not yet reported their voter turnout to please report those numbers to us. It is required by law and we cannot make a complete, statewide report of voter turnout – that the public rightly expects and demands – without information from your communities. This information was certainly known on Election night or shortly thereafter, and by law is supposed to be reported to our office together with election results. A two-week delay in reporting turnout statistics is inexplicable."

The post-election audits can begin as of November 21, 2012 and must be complete by Monday December 3rd.

"Auditing election results isn't just a good idea, it's absolutely essential in order to guarantee the integrity of our elections," said Secretary Merrill. "We don't just take the machines' word for it. So we will have every ballot cast in a full 10% of precincts using optical scan machines hand counted and matched against the machine totals. Connecticut has the toughest elections audit law in the country and I am confident that following this audit the numbers will once again match."

In total, audits will be conducted in 75 precincts. The law requires a hand audit 10% of all polling places where optical scan machines were used in all elections and primaries. (Polling precincts which are already part of a recount are exempt from audits by statute). In addition to the 75 precincts chosen for an audit, there were also 10 alternate precincts chosen. The provisions in the law, developed in close cooperation with the computer science department at the University of Connecticut, give Connecticut one of the strictest audit statutes in the country. Connecticut is the first state in New England to require a comprehensive audit of election results.

Connecticut General Statute 9-320f states that local Registrars of Voters, "... shall conduct a manual audit of the votes recorded in not less than ten per cent of the voting districts in the state, district or municipality, whichever is applicable. Such manual audit shall be noticed in advance and be open to public observation." The results of audits will be analyzed by the University of Connecticut and then presented to the Secretary of the State's Office and the State Elections Enforcement Commission, and ultimately made available to the public.

The law contains a detailed description of the audit process:

"The manual audit... shall consist of the manual tabulation of the paper ballots cast and counted by each voting machine subject to such audit. Once complete, the vote totals established pursuant to the manual tabulation shall be compared to the results reported by the voting machine on the day of the election or primary. The results of the manual tabulation shall be reported on a form prescribed by the Secretary of the State which shall include the total number of ballots counted, the total votes received by each candidate in question, the total votes received by each candidate in question on ballots that were properly completed by each voter and the total votes received by each candidate in question on ballots that were not properly completed by each voter. Such report shall be filed with the Secretary of the State who shall immediately forward such report to The University of Connecticut for analysis. The University of Connecticut shall file a written report with the Secretary of the State regarding such analysis that describes any discrepancies identified. After receipt of such report, the Secretary of the State shall file such report with the State Elections Enforcement Commission."
