Update: Six new agencies launched in Sitecore and nine more to come!

Hot Topic: New Sitecore Release is Close!

We've been working hard on the new Sitecore upgrade and expect a targeted release for the second quarter 2020. As a reminder, this upgrade will have no impact on Content Authors, Content Approvers, or System Administrators, meaning the design and functionality will remain the same as you experience today.

Support: Frequently Asked Questions

1. My password is not changing when I attempt to change it?

You can change your password through the "Forgot Password" link on the <u>Sitecore Login Page</u> or directly through https://egov.ct.gov/UserMgmt/Login.aspx?Display=ForgotPassword.

- When setting a new password, make sure to follow the password policy closely.
- You cannot re-use any previous passwords.
- o If logging in for the first time by copying/pasting your temporary password from our email, make sure to remove any extra spaces.
- o See step-by-step instructions on changing your password.

Just as a reminder, passwords expire every 90 days and can be reset through the link in the password expiration alert emails you begin to receive 14 days prior to the expiration date.

2. Are we able to create shortcuts to specific webpages in the new DEEP website and who would be able to create those shortcuts?

Yes, shortcuts (also known as Aliases, Friendly URLs, or Marketing URLs), can be created in Sitecore by Agency System Admins only. The caveat is the URL will begin with "portal.ct.gov/..." instead of "ct.gov/." 3. Why is the Twitter feed not displaying on my homepage in IE?

Internet Explorer (IE) is not officially supported by Twitter (https://help.twitter.com/en/using-twitter/twitter-supported-browsers), explaining why the Twitter feed is not appearing on the Home Page when using IE.
