Update: Latest Sitecore Enhancements

The latest Sitecore enhancements released on May 10th include:

- System Admins can publish only within their Agency directory.
- Content Authors can publish their Agency's Media Library items, if requested.
- System Admins can unlock or "check-in" all pages and files within their Agency.
- System Admins can delete a page or file and the removal will automatically publish.
- Page version count will be limited to the most recent 15 versions.
- Media Library items will display the appropriate file type icon next to file names.

Feature: Benefits of Internal Sitecore Linking vs. External Linking

When you want to create a link that goes to another source within your Agency website or another Agency within Sitecore, use the Internal Sitecore Link:

- Allows you to hyperlink to any page, Agency topic, dynamic list, or document file that exists within Sitecore.
- If the page you have linked to is moved or renamed, your hyperlink will still work.
- If the page you have linked to is deleted, the individual deleting the page can batch replace or remove your hyperlink from the page. This help keeps the website from having broken links.

Sitecore passwords expire every 90 days. If your password does not change within that time, you will receive daily emails containing password reset reminders, beginning 14 days prior to the expiration date.

- **How do I add Alt Text to my images?**

Adding Alt Text (Alternate Text) to an image is a requirement for complying with Section 508 of the Rehabilitation Act. Alt Text provides alternative information to those who cannot view the image, including those using a screen reader, those with slow connectivity, and search engine robots.
