In order to standardize contributions to CTRB, you should begin 2021-2022 payroll contributions with the payroll check dated September 24, 2021 (pay period ending September 09, 2021).

Two bi-weekly payrolls will constitute a month, to be remitted by the Comptroller's Office to CTRB for the following paychecks:
