SUBJECT: MSA Payroll Schedule Academic Year (AY) 2025-2026

In order to standardize contributions to CTRB, you should begin 2025-2026 payroll contributions with the payroll check dated September 19, 2025 (pay period ending September 4, 2025).

Two bi-weekly payrolls will constitute a month, to be remitted by the Comptroller's Office to CTRB for the following paychecks:

Contributions are based on 8.25% of the annual salary rate, not on actual gross Bi-Weekly Salary. Longevity and MIP/PIP payments are includable in the reported salary on which either 8.25% or 7% is to be contributed, depending on employee vesting date and PA 19-73.
