#### MATTERS FOR BOARD ACTION

- Item 1 A motion was made to approve the June 22, 2011 meeting minutes by Rosalyn Schoonmaker and seconded by William Murray. The motion passed with three abstentions by Michael Freeman, Elaine Lowengard and Gregory Messner.
- Item 2 A motion to ratify the July 2011 COLA, 4.1% for pre September 1992 retirees and zero percentage for those who retired on or after September, 1992, which is the same as granted Social Security for 2011 was made by Rosalyn Schoonmaker and seconded by William Murray. All members voted in favor and the motion was passed.
- Item 3 A motion to ratify, consider and approve the granting of service retirement benefits, survivorship benefits and the reports and recommendations of the Medical Review committee regarding applications for Disability Payments for the month of June was made by William Myers and seconded by Elaine Lowengard. All members voted in favor and the motion was passed.
- Item 4 Recommendations from the Vendor Selection subcommittee for a Medical Plan Third Party Administrator.

Chairperson Barnett turned the meeting to Administrator, Darlene Perez.

Administrator Perez gave an overview of the vendor selection procedures.

There were seven vendors. From those seven bidders three vendor presented final presentations:

Insurance Programmers, Inc.

VSP Vision Care (Vision and Hearing)

Stirling Benefits

The Vendor Selection subcommittee recommended Stirling Benefits for Medical and Hearing and VSP Vision Care for vision.

Darlene asked Joe Fields to speak about VSP Vision Care. Dr. Fields gave a brief description of the benefits and the differences from Stirling Benefits vision.

A motion was made and so moved to approve the recommendations from the Selection Committee and was seconded by William Murray. All members voted in favor and the motion was passed.

Administrator Perez reported on the following activities:

- 1. We had 1262 retirees as of July 1, 2011.
- 2. A subcommittee is needed for Legislation/Policy to discuss and make recommendations to the Board for the following items.
  - a. Post Retirement
