1. Consideration and Approval to Add Proposed Language to the Statute.

Board Members were invited along with Helen Sullivan and Erik Wright (TRB), and Bruce Barth and Alisha Sullivan (Robinson & Cole) to go into Executive Session. A motion was moved by Lisa Mosey and seconded by Greg Messner to go into Executive Session to discuss the written legal opinion of legal counsel regarding proposed legislative language. All members voted in favor and the motion was passed.
