Um, I 40 don't think that that's the alternative that there is right now since there's no 41 alternative language that's been proposed, but, um, I, I, so, so I think the language 42 is good, um, but I am not going to favor, uh, including this as part of TRB's 43 legislative package because I think that, um, we are best off if we leave the plan, 44 um, restricted as much as possible to governmental entities, uh, in order to 45 preserve its status as a governmental retirement plan.
