## CONNECTICUT TEACHERS' RETIREMENT BOARD TRB BOARD MEETING SEPTEMBER 25, 2024

Clare: Okay. So, the July 31st meeting of the Teacher Retirement Board is called to order. Go ahead, Helen.

They are \$54 per member per month, and we'll be moving forward with that contract. So, it's all great news. Keith Norton: We carefully looked through these bids, and there were a couple that were competitive. But you know we were very, very confident in Cigna. We're pleased with what they are offering.

Keith Norton: Currently, we're very pleased with what they're offering. It's clear to us that they are not just sitting back, resting on their laurels and putting forth a bid. But that just continues the good service, they're actually making improvements. They're reaching out to more providers. They're providing more options in terms of providers for our retired teachers. It was a fantastic Bid. Enthusiastically supportive of it.

All the vendors submitted thorough proposals, and I appreciate the work that Terry and her team did to provide us with a valuable interpretation to guide us in this process. But I agree Cigna did a terrific job meeting our members' needs and being responsive to what we're looking for.
