Dear Mr. McPhee,

I am concerned about the proposed Cedar Ridge Apartment Public Water System that was presented in the Environmental Monitor of last week as described below:

"The Cedar Ridge Apartments Public Water System serves the 100-unit Cedar Ridge Apartments in Willington. The public water system submitted a feasibility study to the Department of Public Health (DPH) with alternatives proposed to resolve ongoing water quantity and quality issues and to upgrade its aging infrastructure. The study

identified an interconnection with Connecticut Water Company (CWC) as the most cost-effective, long term option."

I recognize the deadline for comment was February 21st but I believe it is important to find out who has the authority to approve this request and to what extent the town of Mansfield and the University of Connecticut will be consulted in making that decision. The EIE for the Shenipsit water extension to Mansfield came with conditions on the approval of that water extension to Mansfield and UCONN. How will this proposed Cedar Ridge Public Water System be consistent with the EIE approved by the UCONN Board of Trustees?

I would appreciate a response to my concerns regardless of the deadline for the scoping meeting. I would also like to know if there is a separate deadline for comments on the project, apart from the deadline for comments on the scoping meeting.
