# TO ALL COMPANIES LICENSED IN THE STATE OF CONNECTICUT TO WRITE AUTOMOBILE LIABILITY INSURANCE

RE: Insurance Certificates for Van Pool Vehicles

This bulletin contains guidelines and procedures for Insurance Certificates for Van Pool Vehicles required pursuant to Connecticut General Statute. Bulletin PC-41 consolidates and updates information from the superseded and archived Connecticut Insurance Department bulletins NF-59 and NF 104.

#### 1. VANPOOL CERTIFICATE REQUIRED

The owner of a vanpool vehicle must submit evidence to the Commissioner of Motor Vehicles that the vehicle is covered by a policy of insurance or bond which indemnifies the insured against any legal liability for personal injury, death or property damage caused by the use or operation of the vanpool vehicle. The minimum amount of coverage required is \$350,000 per accident. The Vanpool Certificate language and format shown in number 3 below is acceptable to the Department of Motor Vehicles as evidence of required coverage. It must be submitted to the Department of Motor Vehicles in duplicate, both on letterhead of the insurance company providing the coverage. The Department of Motor Vehicles will return one copy to the company address indicated.

#### 2. TERMINATION OF A VANPOOL CERTIFICATE

A vanpool certificate may be cancelled by use of the Connecticut Special Notice of Cancellation or Termination Form IRB3616D. Cancellation must be received by the Department of Motor Vehicles 30 days prior to the effective date of termination. Coverage will terminate on the effective date of cancellation or termination, on the date the insured surrenders the vanpool registration, or on the effective date of replacement certificate, whichever is earlier.
