African American Collections, Inc., Stratford, \$2,000,000

"Rehabilitation of 2225 Main Street, Stratford, CT"

The organization serves individuals, including students and teachers, affording them an opportunity to learn about African American culture by seeing historic artifacts up close and personal. CIF funds will support the rehabilitation of the Sterling Homestead for relocation of the Ruby & Calvin Fletcher African American History Museum.

Boys & Girls Clubs of Greater New Haven, Inc., \$250,000

"Columbus Ave Clubhouse Rehab Planning"

The Boys & Girls Clubs of Greater New Haven (BGCGNH) provides academic and enrichment services in New Haven and the towns of North Haven and Wallingford. CIF Planning funds will facilitate a plan to re-design and renovate the Columbus Avenue Clubhouse in New Haven.

City of Danbury, Danbury, \$943,688

"South Main St. Revitalization Project"

The City of Danbury will utilize CIF funds to repair the roof and make HVAC improvements to the Danbury Community Center on Boughton Street.

City of Meriden, Meriden, \$250,000

"Connecticut Loop Trail Design"

CIF Funds will enable the City of Meriden to design the Central Connecticut Loop Trail from Brookside Park to Giuffrida Park in Meriden.
