Agency Form Contract Updated

Through the authority delegated to executive branch state agencies under General Letter #71, certain purchases of goods and services costing less than \$50,000 may be made without prior and specific approval of the Department of Administrative Services (DAS) provided that a DAS contract does not exist for the goods and/or services being acquired. Executive branch state agencies should be aware that all contracts entered into must be approved as to form by the Attorney General.

The changes to the contract are as follows:

1. Section 5(b) contains updated language concerning statutorily mandated minimum wage price adjustments.
2. A new optional Section 5(e) was added which includes language regarding standard wage price adjustments. That Section also requires the creation of an Exhibit D to the Contract which would include standard wage rates as well as certain other language.
3. Section 33 concerning applicable executive orders was replaced with a new section including updated language reflecting Governor Malloy's Executive Order #49.
