NEW Contract for Maintenance, Repair and Operations Supplies and Equipment

Effective August 1, 2018, DAS executed a new contract #17PSX0232 for Maintenance, Repair and Operations (MRO) supplies and equipment. The new contract is a multi-state cooperative contract through NASPO ValuePoint and Connecticut is a participating entity in this contract which can be found on the State Contracting Portal, https://biznet.ct.gov/SCP Search/ContractDetail.aspx?ID=19907.

There are four vendors that have been awarded this contract for the State of Connecticut: Fastenal Company, Noble Supply and Logistics, W.W. Grainger, Inc. and SID Tool Co. dba MSC Industrial Supply Co., Inc.. This contract replaces the expired MRO contract 10PSX0204 (previously solely with Grainger). This MRO portfolio offers tools, supplies and equipment to maintain, repair and operate buildings, grounds and facilities and offers significant opportunities for savings. NEW Contract for Professional Grade Tools and Diagnostic Equipment

Effective September 1, 2018, DAS executed a new contract #17PSX0235 for Professional Grade Tools and Diagnostic Equipment. The new contract is a multi-state cooperative contract through NASPO ValuePoint and Connecticut is a participating entity in this contract which can be found on the State Contracting Portal, https://biznet.ct.gov/SCP Search/ContractDetail.aspx?ID=20032.

Three vendors been awarded this contract for the State of Connecticut: Hilti, Northern Safety Co. Inc. and Snapon Industrial, a Division of IDSC Holdings LLC. This contract replaces the expired contract for Small Hand & Power Tools - Contract Award 17PSX0051. The new contract contains two components: 1) Professional Grade Tools – as compared with general use or consumer grade products. The intent is to provide more durable products with the expectation that purchases will work better and last longer in an environment where they are used more regularly. Items on this contract are built for extended heavy and repeated use, are more rugged, tend not to malfunction as quickly, and are typically associated with better features and options. 2) Diagnostic Equipment – This category offers products used for automotive, electrical, plumbing, or other specialized areas that require unique diagnostic analysis with the exception of medical diagnostic equipment.


