Promoting Women in Construction




DAS was thrilled to participate in the National Association of Women in Construction's *Women in Construction Week* celebration in Hartford.

The diverse perspectives and skills of women are critical to the success of projects. Women's lived experiences contribute to making our job sites better, and DAS stands committed to uplifting women in the construction space.

DAS has long sought to open up opportunities for women and people of color through initiatives such as the Supplier Diversity Program. The upcoming release of the state's disparity study, thanks to CHRO for leading, with DAS's active participation, will provide concrete recommendations for improving these opportunities even further.

COMING SOON: The New DEEP Western

District Headquarters Opening



Stay tuned: DAS and DEEP will soon share details on an opening ceremony for the new DEEP Western District Headquarters, located within Black Rock State Park in Watertown. Local park rangers and ENCON Police, have begun moving into the new facility, which includes the following features:

Trombe Wall – the southern facade features a Trombe wall that absorbs thermal energy for heating and promotes the circulation of air for natural ventilation.

Geothermal – 16 geothermal wells, 500 feet deep with four 10-ton water to water heat pumps heat and cool the building. Additionally, a 5-ton water to water heat pump provides domestic hot water.

Photovoltaics – the building's roof holds 186 solar panels, generating 73kW, estimated to provide 105% of the building's annual electrical needs.

Enhanced Building Controls – alarms and troubleshooting building controls are tightly monitored within the building to obtain a net zero goal.

Heat – Areas of the building are zoned with geothermal-fed hot water in-floor radiant heat.

Ventilation – Ventilation systems incorporate energy recovery "heat wheels" mounted within air handling equipment.

Carbon Reduction – Materials, systems and assemblies were selected to reduce embodied carbon in the construction of the building, and eliminate carbon in the operation of the building.

Site Development – Stormwater management and native plantings ensure minimal impact on the environment by cleaning water before it drains to the wetlands and eliminating the need to mow or water groundcover.

The building is designed to LEED Platinum and net-zero design standards and is operated free of fossil fuels.



DAS Fleet Operations Wins Geotab Award



The DAS Fleet Operations team was recently recognized with a 2024 Geotab Innovation Award for Excellence in Safety!

The Geotab Innovation Awards recognize organizations that are leading the way in their use of connected vehicle technology and data insights to drive better outcomes for business, people and the planet.

The winners are scored and selected based on their implementation and performance compared to similar fleets. A new category, the Geotab Awards of Excellence (Safety Champion and Maintenance Champion) is based on nominations by Geotab partners, customers and industry peers, and recognizes fleets for performance, management, innovation and impact.
