Opening the Applied Innovation Hub



Earlier this month, the DAS team joined Governor Lamont and colleagues from Central Connecticut State University and the CSCU system to officially cut the ribbon for the Applied Innovation Hub, the four-story, 87,000 square foot state-of-the-art academic building that now houses many STEM-related courses and programs. It also includes an extended reality lab -- which gives students the opportunity to work with immersive technologies such as virtual reality and augmented reality -- in addition to robotics and mechatronics spaces.

DAS was proud to administer the \$54 million project. The building serves as a testament to the state's commitment to fostering the next generation of engineers and innovators.
