## Fleet Software

As we mentioned a couple of months back, Fleet Operations is in the process of purchasing new software to assist with managing our more than 3,500 vehicles. Over the past month staff members have been testing and debugging the new Chevin FleetWave software. The current projection is that it will be ready to launch in September.

The plan is that once it's ready to go the new software will fully replace Fleet Anywhere and Biznet applications. Mileage, billing, etc. will be handled through the FleetWave program. As the go-live date nears we will be sharing system information and screen shots to assist ATAs and their support staff with the transition. Stay tuned for additional information.

## Car Washes

Fleet Operations is happy to announce the addition of a new car wash location! Russell Speeders in Manchester is now able to provide their services to all DAS vehicles. The process is the same as at all other locations. Just fill out the back of either a Wash Only, or Full Service coupon and provide it to the attendant. The vendor then bills DAS monthly to settle up.

Russell Speeders is in the Buckland area, just off exit 63 of I-84, at 44 Hale Road. This location provides coverage in a convenient east of the river spot that is in close proximity to where many vehicles are domiciled.
