- LF made a motion to approve the amendments to the Connecticut State Building Code. Second from TD. After discussion LF rescinds vote to accept document as is. TD rescinds second.
- Comments made by Michael Sinsigalli, concurred by Keith Flood, regarding reservations on code initiatives dealing with affordable housing due to the reduced life safety measures.
 Both members to vote against the Connecticut State Building Code package and the Connecticut State Fire Code package.
- Comments made by Michael Musco, Anthony Cinicola and Paul Costello regarding pg 36, 907.2.11.2 with groups R2 R3 R4 and I1 dealing with single multiple station smoke alarms to remove the reference to occupant load language to be deleted [regardless of occupant load] to stop confusion among professionals and improve safety.
- Comments made by Donald Harwood regarding single exit provisions. Personal and professional concerns/trepidation on life safety. Does not believe the single exit provisions were worked out. NFPA also hasn't reviewed it as a standard.
- PC makes motion to accept the suggested revision from electrical work group on pg 36, 907.2.11.2 with groups R2 R3 R4 and I1 dealing with single multiple station smoke alarms to remove the reference to occupant load language to be deleted [regardless of occupant load]. MM second motion. All in favor.
