At its meeting held on May 1, 2014, the State Properties Review Board voted to suspend the above referenced item, pending receipt of additional information regarding the rental rate. The stated rental rate was \$128.74/pay period (bi-weekly), but no appraisal report was provided to substantiate the rate.

DAS has re-executed a lease with this tenant with the same standard terms and conditions previously reviewed, except that the rate has increased to \$177.01/pay period, based on a new appraisal indicating that the market rent for the subject dormitory unit is \$6,600/year (\$550/month). The policy in place established rent at 70% of the market rent, and deducted over 26.1 pay periods per year:

66,600/year x 70% = 4,620/year $\div 26.1$ pay periods = 177.01/ypay period (bi-weekly)

Staff recommended Board approval of the item. DMHAS has certified that the Lessee is a mental health worker and assigning state-owned housing quarters would facilitate the employee's ability to direct, manage or maintain the health, safety and welfare of clients. The rental rate is based on a recent appraisal that established the rental rate at \$550/month for the dorm unit. As a result of the Board's review, the revised lease will increase revenue to the State by \$2,519.77 over the two year lease term.

Staff reported that this is the 7th series of On-Call Civil-Survey Consulting Contracts awarded by the Department of Construction Services ("DCS") since 2002. The six On-Call Contracts that are the subject of this memorandum have a maximum total cumulative fee of \$500,000 per contract and a common expiration date of 06/30/2017.

This is the first time that AI Engineers, Inc., Freeman Companies, LLC and Martinez & Couch Associates, LLC has been awarded a contract under this series. Fuss and O'Neill, Inc. was awarded contracts under the 1st,5th and 6th Series, BSC Group-Connecticut, Inc. was awarded contracts on the 2nd and 4th series and CLA Engineers, Inc. was awarded a contract on the first series.

A Request for Qualifications for the consultant services was released in June 2014 and elicited 22 responses. One of the respondents was considered "unresponsive" and as such twenty-one submittals were considered for review. Thereafter, the DCS selection panel began the process of evaluating all 21 proposals. The State Selection Panel consisted of 3 members and rated each firm based upon a weighted ranking system.

Staff recommended Board approval of the 6 contracts referenced above. All of the consultants have provided the required insurance, Gift/Campaign and Consulting Affidavits accompanied by appropriate Corporate Resolutions.
