**Property:** Generally located along the Norwich Little League Complex, Norwich

**Project Purpose:** Lease of vacant land, DOT Agreement No. 10.16-02(14)

*Item Purpose:* Five-year lease with two-five year renewal options for  $1.1 \pm acres$  of vacant

land located along State Route 2 and Wawecus Street for recreational purposes

as part of the Norwich Little League Complex.

Staff reported that for many years the State of CT through DOT has leased to the City of Norwich 1.11 acres for recreational purposes located off Wawecus Street between State Routes 2 and 32 and the Norwich Little League Complex.

PRB #15-159 is a new lease that will continue the use of the property by the City. The terms allow a five year lease with two additional five year renewal periods. Either part can terminate with thirty days' notice. The City pays any costs associated with the lease, including utility and maintenance costs. DOT has standard highway lease specifications that apply and are attached as a part of the lease document.

Staff recommended Board approval of the item. The commissioner of transportation has the authority under CGS §13a-80 to enter into lease agreements, subject to the approval of OPM (received 06/30/2015) and the SPRB. By City Resolution dated April 6, 2015, the City Council approved the subject lease agreement and authorized the Acting City Manager to enter into the lease agreement on behalf of the City. The City has provided an insurance certificate dated 7/7/2015 indicating that the required liability insurance is in place.
