**DOT PROJECT:** As part of the project known as New Haven Rail Yard Facilities Improvements West End Yard, a proposed easement for providing access to the State Rail Yard within an easement area of  $4,315\pm$  SF of land is sought. The easement taken will not impede the normal flow of the driveway or access to parking and refuse areas. The

easement will allow for maintenance of said access way. <u>There are no impacts to parking</u> or improvements.

Subject Property Description, Before the Taking: The subject property is composed of a  $1.17\pm$  acres.

Location:	104 Food Terminal Plaza
Site Area:	$1.17\pm acres$
Use:	Industrial Wholesale

The DOT Taking: DOT will take the easement as detailed in the table below.

**EOC Valuation:** Consistent with DOT's agreement with FHWA an estimate of compensation (EOC) worksheet has been prepared for the subject taking. This process is used for simple acquisitions related to minor site improvements where the total cost is typically less than 10,000. In this instance, the appraiser valued the site at 104 Food Terminal Plaza in New Haven at \$8.50/SF. The following table indicates the results of the DOT Estimate of Compensation, prepared as of 4/10/2018:
