1. Welcome

Chair Kelli-Marie Vallieres opened the meeting, welcomed attendees, and highlighted the evolution of P20 WIN.

4. DataLinkCT

Katie presented the final rollout materials for the rebrand of P20 WIN to Datalink CT. Branding was developed with Cronin Communications, and they produced materials including the new name, logo, letterhead, brochures, slide templates, and one-pagers. A full transition to DataLinkCT is planned for July 1, 2025.



5. System Improvements Update

Katie Breslin and Adriana Sanchez-Dominicci provided updates on the system improvements and modernization efforts.

Secure Data Enclave:

Katie and Adriana presented on the enclave's hybrid cloud development in Azure. The focus includes auditing and monitoring controls, user-based permission, legal compliance, agency control, data privacy, security and protection.

Policy Development:

Katie gave the Board an update the policy development underlying the enclave development.

6. Legislative Updates and Reports

Statewide Data Intermediary report and WestEd presentation

Chair Vallieres reminded the Board of the second requirement that came out of PA 24-45 – to develop a plan to establish a statewide data intermediary. LeAnn Fong of WestEd presented study findings on creating a nonprofit-state data intermediary for disconnected youth. Recommendations included resources and funding, building trust among data contributors, ensuring data security, and piloting a model.

SB 1250 An Act Implementing the Governor's Budget Recommendations for Higher Education

Chair Vallieres commented on the passage of SB 1250. The legislation designates OPM as P20 WIN administrator. Reporting requirements for the Workforce Development Boards and public institutions of higher education to submit data are included.

7. Legal Agreements

Katie shared that updates are underway for the next version of the Enterprise MOU (E-MOU), incorporating shared terms and universal content from DSAs. The new structure limits Data Sharing Agreements to state agencies and Data Use Licenses for data requesters.



8. Data Requests

Katie gave an overview of data requests by Learning Agenda topic as well as requests in each phase of the data request process. Demand for data requests is the highest it has ever been.

Education & Workforce Pathways

Rachel Leventhal-Weiner provided an update on a major ongoing project that is analyzing wage and employment outcomes for participants in education and workforce programs.

9. General Updates

Agency transition

Scott Gaul announced ACT (Advancing Together CT) will become the HMIS lead agency on July 1, 2025. Nutmeg Consulting remains administrator.
