

DataLinkCT is Connecticut's version of connect the dots: linking data between different state agencies to build a bigger picture. As each member agency works to serve Connecticut residents, DataLinkCT is designed to make connections between that work and move us forward.

About DataLinkCT (formerly P20 WIN)

<u>DataLinkCT (formerly P20 WIN)</u> is Connecticut's state longitudinal data system and facilitates the sharing and linking of data from multiple agencies to address critical policy questions.

The DataLinkCT mission and vision is to inform sound policies and practice through secure sharing of longitudinal data across participating agencies to ensure that individuals successfully navigate supportive services and educational pathways into the workforce.

DataLinkCT (P20 WIN) is a decentralized data system where Participating Agencies maintain the data they collect for administrative purposes. Agencies must approve and authorize the release of any data before it is shared.

DataLinkCT is used to answer policy questions, fulfill federal and state reporting requirements; support program review; provide employment and wage outcome data; and support research and analysis on a variety of topics.

Governance

The DataLinkCT <u>Executive and Data Governing Boards</u> are responsible for developing and implementing policies and procedures necessary for a multi-agency data sharing system. DataLinkCT is administered by the Office of Policy and Management (OPM). The Department of Labor is the Data Integration Hub and conducts all data matching for approved data requests.
