# New Pharmacy Application (s)

**Commission Action:** Commissioner DeFazio moved, seconded by Commissioner Chisolm, and passed by a vote of 5-0, to approve the above request for a new pharmacy premise provided all the requirements set forth in the Connecticut Pharmacy and Drug Laws as enforced by the Commission of Pharmacy are met.

#### Pharmacy Relocation (s) Cont.

**Commission Action:** Commissioner Chisolm moved, seconded by Commissioner Taylor to approve the above relocation request passed, with the separation from the pharmacy clinic by a vote of 5-0 to and provided all the requirements set forth in the Connecticut Pharmacy and Drug Laws as enforced by the Commission of Pharmacy are met.

#### Legal

Case Number: 2024-573 Pharmacist Thor Huntley; PCT.0011026

Attorney Michael Ando presented this case.

Respondent is a Connecticut Pharmacist who is the spouse of another Connecticut Pharmacist. The investigation into case number 2023-2147 led to this case being opened. Respondent is alleged to have been negligent in the performance of his pharmacist duties, including dispensation of fraudulently obtained prescriptions of non-controlled drugs to family members.

# **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$4,000 and his pharmacy license shall be on probation for a period of one year from the date of the acceptance of the agreement. Respondent has also voluntarily completed two continuing education classes. Commissioner DeFazio stepped down on this case.

**Commission Action:** Commissioner Inguanti moved, seconded by Commissioner Linder and passed by a vote of 4-0 to accept and approve the aforementioned settlement agreement.

Case Number: 2023-477 McKesson Corporation; CSW.0003956

Attorney Michael Ando presented this case.

Respondent is a Connecticut Wholesaler of Drugs, Cosmetics, and Medical Devices which was investigated upon discovery by a Drug Control Agent of an unsecured vehicle containing controlled substance delivery totes during an unrelated investigation. The delivery vehicle was found to be unlocked with no employees present during the time of the delivery.

## **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$1,500, which has been paid. Respondent has voluntarily addressed alleged violations to conform with their existing policies and law.

**Commission Action:** Commissioner Taylor moved, seconded by Commissioner Linder and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

# Legal Cont.

Case Number: 2023-1206 CVS/Pharmacy #16603; PCY.0001790

Attorney Michael Ando presented this case.

Respondent is a Connecticut Pharmacy investigated following a routine compliance inspection. Respondent pharmacy is alleged to have failed to report the absence of a pharmacist manager timely following more than sixteen consecutive days of absence, failed to conspicuously post the name of the pharmacist manager, and failed to maintain written records of pharmacy technician training. The location was operating with a de facto pharmacist manager following the departure of the previous pharmacy manager, however the Commission of Pharmacy was not notified of a change, nor was signage updated. The technician training records were not updated for approximately two years.

# **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$1,000, which has been paid. Respondent further agrees to notify the Commission of Pharmacy of changes in pharmacy management as required by law and ensure manager duties are carried out even during transition periods.

**Commission Action:** Commissioner Inguanti moved, seconded by Commissioner Linder and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Case Number: 2023-1206 CVS Pharmacy #1098; PCY.0001020

Attorney Michael Ando presented this case.

Respondent is a Connecticut Pharmacy investigated based on information obtained in an unrelated investigation that indicated the pharmacy may have been staffed out of compliance with State of Connecticut regulations concerning pharmacy technician ratios. Respondent pharmacy is alleged to have staffed the retail pharmacy location at a ratio of up to six technicians to one pharmacist. None of the technicians were nationally certified. Pharmacy Technician staffing ratio was alleged to have occurred in more than one compliance inspection by Drug Control agents in a one month period, even after initial advisement.

#### **Proposed Resolution:**

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$1,000, which has been paid. Respondent pharmacy shall be issued a Letter of Reprimand.
