February 8, 2022

The scheduled meeting of February 8, 2022, was held via Zoom.

Anthony L D'Andrea, Chairman called the meeting to order at 9:03 am.

**Minutes-** Motion made by (10) seconded by (5) to approve the January minutes as amended. Motion carried.

### **A-Correspondence Received**

A-1 Robert Zygmunt- A discussion regarding SE licensure. (Dist. 2)

Robert Zygmunt appeared before the regarding proposed legislation regarding SE licensure.

The board stated that based on their past policies and decisions, the Board would not waiver from the position that would require passing the NCEES PE exam after four years of practical, qualifying engineering experience after completing the accredited engineering degree.

It is the opinion, that the graduate engineer is likely to start working and after four years of broad-based experience would take the PE exam. During those four years, the applicant may decide that concentration on structural design is where they would prefer to be.

At that time, passing the SE exam would establish the person as qualified to design the threshold structures.

The Board would also support continuing education for Structural Engineers for the reasons enumerated in the presentation, including the constantly changing technology and codes.

**Motion made by (7) seconded by (2) that the Board would support the SE license with the understanding that individuals under this special discipline must take the PE test and hold a PE license first before taking the 16-hour SE Exam. Motion carried.**

Mr. Zygmunt stated that they will revise their FAQ' and bill per the Board's comments and will proceed with the legislation. Proposed bill as stated, will require a SE to take and complete the PE test first before taking the 16-hour SE test. A SE would have two licenses (PE and SE) and pay one licensing fee a year.

A-2 Email from Scott A Hill from the DOT- Use of DocuSign to sign Project Plan. A representative from DOT may attend to provide any additional information (Dist. 4)

Bill Pratt from the Department of Transportation stated that his agency is moving toward the use of DocuSign as a business practice and wanted to verify if this software can be used to digitally sign final engineering plans for construction.

The Board and the engineers from the DOT held a brief discussion. The Board agreed to give their support for this type of software
