- Question: What are the qualifications and training for translators? Are they certified? / Answer: The interpreter services being used are certified, and the language line is certified as well.
- Families need to be made aware they can request a Spanish speaking Case Manager.
- Dr. Ellis, DDS Directors of Diversity, Equity, and Inclusion offered to get information for the committee on translation services used by DDS, and languages spoken by Case Managers.
