COUNCIL ON DEVELOPMENTAL SERVICES report to STS BOT 1-22-24

A report was given by Diana Mennone, STS Board of Trustees representative for the DDS Council on Developmental Services covering meetings held virtually on October 19, 2023 and November 30, 2023.

Commissioner Scheff updated the Council on the continued forums and virtual updates with stakeholders around the state. He attended the NASDDDS (National Association of State Directors of Developmental Disabilities Services) conference in November 2023 and he also addressed the RACs (Regional Advisory Councils) at a joint annual meeting with the Council on Developmental Services that same month.

Each Advisory Council shared information on similar topics including the STEP initiative (Supporting Transformation to Empower People). ARPA (American Rescue Plan Act), the housing shortage, new membership redevelopment and participation from the public.

The DDS Council gave a report to the RACs sharing that the Council had testified before the legislature on the state budget, House Bill 5001 and on the reappointment of Commissioner Scheff.

The Council also participated in many of the same presentations as the RACs. Shannon Jacovino, DDS Ombudsperson reported on families who have been struggling to find support for their family members with high levels of need. She will update the Council on progress in options being explored.
