SUBJECT: Electronic Visit Verification updates

The purpose of this memo is to provide updates on Electronic Visit Verification (EVV):

- Visit Rounding Rule
-Sandata Mobile Connect Version 2 application

EVV Visit Rounding Rule

The Department of Developmental Services (DDS) has moved from a per day to per visit rounding method for EVV visit processing during the last week of January 2024. DDS receives the minute values that correspond to each visit and divides that total by 15-minute increments, rounding to billable units. If subsequent visits are documented for the same day, service, and individual, the minutes for that visit would be rounded to units and then aggregated to yield daily units. Any visits and/or units submitted before the release of this memo are not required to be shifted to the new rounding rule.

15 minutes = 1 billing unit

Example #1 -
EVV clock in - 9:10
EVV clock out - 11:12
= 122 minutes/15-minute increments = 8.13 units rounded to 8 billable units

Example #2 -
EVV clock in - 9:10
EVV clock out - 11:18
=128 minutes/15-minute increments = 8.53 units rounded to 9 billable units
