Insurance Committee Public Hearing – Tuesday, February 28, 2012

DDS Testimony before the Appropriations Committee, the Program Review and Investigations Committee and the Commerce Committee

The **Insurance and Real Estate Committee** is holding a public hearing on Tuesday, February 28, 2012 on the Department of Developmental Services' bill <u>S.B. No. 205</u> AN ACT CONCERNING INSURANCE COVERAGE FOR THE BIRTH-TO-THREE PROGRAM.

This bill allows the Birth to Three System to count insurance payments for Birth to Three services towards the federal IDEA mandate for "maintenance of effort" and establish a new baseline of state and local expenditures for early intervention services in the next federal fiscal year pursuant to federal regulations.
