The first hour of the hearing is reserved for Legislators, Constitutional Officers, State Agency Heads and Chief Elected Municipal Officials. Speakers will be limited to three minutes of testimony. Bills will be heard in the order listed in the Bulletin. Unofficial sign-up sheets have no standing with the Committee.

On either the "Public Hearing Date" page or the "Bill Number" page there will be links to all the testimony submitted on a particular bill.
