### Information provided by the provider describing their agency:

DDN Consulting Service has been serving individuals with developmental disabilities providing nursing oversight for over 14 years.

Throughout this time we have met many individuals who were not qualified to receive medical care but still had significant medical needs. These individuals were left to rely on community based resources, who didn't understand them or their medical needs. Visiting Nursing Agencies and Medical Clinics were never designed to manage the care of these individuals and are not familiar with DDS regulations and requirements. Unfortunately, even with our help, many of the basic preventive care guidelines for these people could not be met.

We developed DDN Healthcare Coordination to meet the growing need of these individuals. Now with our team of Qualified Health Coordinators, working to coordinate the medical care of the people we serve, we are more successful. Working with a DDNCS Qualified Health Care Provider you or your family member will have not just a nurse, but an advocate, and health educator. We will collaborate with community providers, individuals and their families to be sure all of the needs are being addressed. Our Team is well trained and backed up a network of DDNCS Qualified Health Care Coordinators are always available.
