CVS, Inc.'s Mission is based upon three guiding concepts: Integration, Independence and Productivity. CVS staff implement a person's Individual support plan (ISP) that includes choices related to these three concepts. A team approach is used to arrive at goals, decisions, choices and directions for each person with their input, their families, staff and Case Managers.

Day Services are mostly community based and one part of day services also utilizes a home base or hub for offering services.

24-hour Residential Services are offered at homes rented by residents and operated/supported by CVS staff. Others receive residential supports in their own apartment or home residing more independently.

Day and Residential Services can range from community jobs, volunteerism, social, recreational connections and networking within the community. These supports can have a range of staff hours depending on each person's needs.

Flexibility is a key factor with services and supports offered by CVS, Inc. as is listening to what people choose and obtain their families perspective. As systems and services change and become increasingly connected to the community, CVS, Inc. is there for support and assistance to ensure those served have opportunities to try new things and from there make decisions that will affect their future.
