Marrakech is a diverse nonprofit organization that has been providing person centered, unique, and cost conscious human services for children and adults, with and without disabilities, in Connecticut for over 40 years.

The services we provide include career training and support, chronic medical and behavioral treatment, safe affordable housing, family support and access to community resources. Out of the multitude of services provided the two shared outcomes are improved self sufficiency and quality of life.

Marrakech provides center based day program supports in West Haven, Waterbury and New Milford, and individualized day program supports Statewide.

Marrakech offers a wide variety of residential supports including Group Homes, Continuous Residential Support, Community Companion Homes, and Individualized Home Supports in family homes or independent living arrangements.

Marrakech is nationally accredited through CARF International for supported living, group homes, employment services and community integration services.

Marrakech has a popular quality of life program that offers a variety of community based activities as well as specialized and popular events such as a theater group, annual formal ball, self advocacy group, Thanksgiving Feast, Holiday Parties and Special Olympics Teams.
