Notice is hereby given that a public hearing will be held by the Administrative Law Unit and Administration, located at 2800 Berlin Turnpike, Newington, Connecticut, on April 24, 2026, at 10:00 AM in Docket No. 2510-N-105-T for the application of Dimple Taxi, LLC.

Pursuant to the provisions of Sections 13b-97 and 4-177 through 182 of the Connecticut General Statutes (C.G.S.) Dimple Taxi, LLC seeks authorization to operate three (3) motor vehicle, in taxicab service within, and to and from Branford, Bridgeport, Cheshire, East Haven, Hamden, Hartford, Milford, New Haven, Wallingford, and West Haven.

This hearing will be held in person at the above address. Any participant who is unable to attend in person may request to participate remotely. Remote hearings will be conducted via Microsoft Teams.

If you wish to participate via Microsoft Teams, you must send an email to the Administrative Law Unit with the docket number, name of the case, hearing date and valid email addresses for yourself. If you do not send an email to the Administrative Law Unit, the remote link cannot be forwarded. While remote participation by video is preferred, telephone participation will also be available using the same link. A separate email invitation with an access code or a Teams meeting link will then be sent.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request intervenor or party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case or that the interests of justice would be served by their participation and that their participation will not impair the orderly conduct of the proceedings.

All party or intervenor status requests must be submitted in written form and received by the Administrative Hearing unit no later than five (5) days prior to the date of the hearing, otherwise such requests shall be subject to denial without a showing of good cause for the late request. Copies of the request must also be sent to the applicant and all known parties.

The original and 4 (4) copies of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party or intervenor must be filed with the Administrative Law Unit no less than 7 days prior to the date of hearing.

If the hearing is postponed due to inclement weather, it will be rescheduled for the next available date and a new notice issued.
