The records of the Department of Transportation indicate that the Respondent Luxe Ambassador Transportation of Hartford, Inc. is the holder of Livery Permit Number 3724. The Records of the Department of Transportation further indicate that Luxe Ambassador Bus Lines Inc., is the holder of Bus Permit Number P-585. The records of the Department show that Elite Limousine Service, Inc., dba Elite Limousine is the holder of Livery Permit No.P-2341.

The records of the Department further indicate that these Respondents are allegedly in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

- Connecticut General Statutes, Section 13b-103(c): Sale of Permit
- Connecticut General Statutes Section 13b-86: Jurisdiction of Department

The alleged incident at question violates the terms of the permit that require permitholders to comply with all pertinent laws and other statutes, rules, regulations and orders of the Department

More specifically, the Department of Transportation has become aware that Luxe Ambassador Transportation of Hartford, Inc. (Permit 3724) and Luxe Ambassador Bus Lines of Hartford, Inc. (P-585) were sold to Elite Limousine Service Inc, dba Elite Limousine P(2341) in a stock purchase and sale agreement executed in February of 2025. The sale and transfer were not approved by the Department.

Pursuant to Connecticut General Statutes Section 13b-103(c), you are hereby directed to appear at the address above on April 2, 2026, at the Department of Transportation, 2800 Berlin Turnpike, Newington, Connecticut to show cause as to why your permits should not be revoked, suspended, and/or whether a civil penalty should be imposed for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.

Parties and intervenors requiring an interpreter (translator) for this hearing must notify the Department of Transportation by contacting the Department's Administrative Law Unit at (860) 594-3012 at least five (5) working days prior to the hearing.
