Pursuant to Connecticut General Statutes Sections Section 13b-343, the Office of Rail and Division of Traffic Engineering, petitioners, seek to upgrade existing railroad appurtenances at the railroad crossing at Long Ridge Road in Redding by modernizing railroad flashing lights and installing vehicular gates.

In order to obtain PARTY STATUS:

- 1. A written petition must be submitted to the agency;
- 2. A copy of such petition must be mailed to all know parties (usually the Petitioner); and
- 3. The petition must state facts that demonstrate that the petitioner's LEGAL RIGHTS, DUTIES OR PRIVILEGES will be SPECIFICALLY AFFECTED by the agency's decision.

In order to obtain INTERVENOR STATUS:

- 1. A written petition must be submitted to the agency;
- 2. A copy of such petition must be mailed to all known parties (usually the Petitioner) and
- 3. The petition must state facts that demonstrate that the Petitioner's participation is in the INTEREST OF JUSTICE AND WILL NOT IMPAIR THE ORDERLY CONDUCT OF THE PROCEEDING.

All petitions and certification of party notification must be received by this agency five (5) days prior to the date of hearing; otherwise such requested status shall be subject to denial.

An original and FOUR (4) copies of all prepared documents and exhibits intended to be introduced as evidence in this matter by the Petitioner and any other party or intervenor must be filed with the Department not less than FIVE (5) days prior to the date of hearing.
