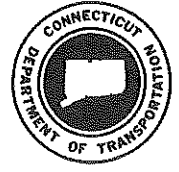

The records of the Department of Transportation (department) indicate you are the holder of Livery Permit Number 3672. The records of the Department further indicate that you are allegedly in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

- CGS Section 13b-103, 4-182 and State Agency Regulations, as amended, by violating the terms of the permit which require the permit holder to comply with all pertinent laws and other statutes, and/or rules, regulations and orders of the Department.

More specifically, on June 7, 2021, Teresa Angeski emailed the Department a Connecticut Emissions Test for a 2016 Dodge Caravan. Upon review of that document, the Department noticed that marker plate L00788L was used for that test. When we cross-checked that plate with CIVLS (DMV registration system), we found that the plate is currently registered to a 2014 Toyota Sienna which is also currently owned by Advance Livery, LLC, bringing to the attention of the Department that Advance Livery, LLC could allegedly be in violation of the following:


- Connecticut General Statutes:
 - o Sec.13b-103.Permits. Display of Permit. Amounts remitted to municipality.
 - o Sec.4-182. Matters involving licenses.
 - o Sec.14-147(c). Use of motor vehicle registration on vehicle other than that for which such registration has been issued.

- Regulations of Connecticut State Agencies (RCSA):
 - o Sec. 16-325-8. Limitation on number of vehicles operated.
 - o Sec. 16-325-9. Vehicles to be approved by commission.
 - o Sec. 16-325-17. Display of name of permit holder and identifying number.

As a result of the above, you are subject to a citation hearing pursuant to CGS 13b-103 and a sanction pursuant to CGS 4-182. You are hereby scheduled for a telephone hearing on August 19, 2021 at 10:00 AM for a Show Cause hearing as to why this Certificate should not be revoked, suspended and/or the imposition of a civil penalty for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.
