# NOTICE OF CITATION HEARING WWW.CT.GOV/DOT

The records of the Department of Transportation indicate you are the holder of livery permit number 3505. The records of the department further indicate that you are allegedly in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies: CGS Section 13b-103, 4-182, as well as State Agency Regulations Sec. 16-325-9, as amended, by violating the terms of the permit which require the permit holder to comply with all pertinent laws and other statutes, and/or rules, regulations, and orders of the department.

More specifically, on September 14th, 2022, the Department of Transportation received a complaint that you are allegedly operating unregistered vehicles in livery service. Upon further review, our records indicate that you are also potentially out of compliance for several reasons listed below:

#### **Connecticut General Statutes:**

- The status of your FMCSA certificate is currently inactive violation of CGS 13b-102 & 13b-109.
- There is no active insurance on file violation of CGS 14-29.
- There are no active registrations under your permit, all have expired—violation of CGS 13b-106, 14-26, & 14-27.
- Your criminal history and fingerprinting requirements are two years overdue violation of CGS 13B-102.

### Regulations of Connecticut State Agencies (RCSA):

• Our 15-Day letter was undeliverable to the address on file. The permit holder did not notify the commission in writing of any changes in business address – Violation of Regulations of Connecticut State Agencies: Sec. 16-325-3.

- The permit holder changed the location of his headquarters to a point outside the city or town specified in his permit without prior commission approval Violation of Regulations of Connecticut State Agencies: Sec. 16-325-4.
- Vehicle used for livery was not approved by commission violation of Regulations of Connecticut State Agencies: Sec. 16-325-9.

As a result of the alleged violations, you are subject to a telephone citation hearing pursuant to CGS 13b-103, and you are subject to a penalty pursuant to CGS 13b-108 in accordance with CGS 4-182. You are hereby directed to appear at a telephone citation hearing on November 8, 2022, at 10:00 AM for a Show Cause hearing as to why this Certificate should not be revoked, suspended, and/or imposed a civil penalty for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.
