The records of the Department of Transportation (Department) indicate you are the holder of Livery Permit Number 3172. The records of the department further indicate that you are allegedly in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

• CGS Sections 13b-102, 13b-103, 13b-106, 4-182 and State Agency Regulations, as amended, by violating the terms of the permit, which require the permit holder to comply with all pertinent laws and other statutes, and/or rules, regulations, and orders of the department.

More specifically, On July 12, 2023, the department received a complaint alleging that your company was improperly operating a vehicle in livery service. The complaint details an alleged incident on July 10, 2023, when a customer was picked up at Bradley Airport and transported to their home in Berlin by Lord's Way Limousine Services LLC dba Avon Limousine Worldwide. The complaint further alleges that the black Chevy Suburban did not have livery plates or a front license plate, no identification on the driver or the vehicle, and the check engine light was on. After investigating the alleged incident, the department has found cause to challenge the suitability of the management for this permit. The findings indicate that Lord's Way Limousine Services LLC could be in violation of the following:

- Connecticut General Statutes:
- o Sec. 13b-103: Permits. Display of permit. Penalty. Amounts remitted to municipality. Revocation of Permit.
- o Sec. 13b-106: Registration; display of registration; lights; license.
- o Sec. 4-182: Matters involving licenses.
- o Sec. 14-147: Improper use of marker, registration or license.

- Regulations of Connecticut State Agencies (RCSA):
- o Sec. 16-325-3: Notice of change of address.
- o Sec. 16-325-4: Change of location outside of city or town.
- o Sec. 16-325-7: Rates.
- o Sec. 16-325-8: Limitation on number of vehicles operated.
- o Sec. 16-325-9: Vehicles to be approved by commission.
- o Sec. 16-325-17: Display of name of permit holder and identifying number.
- o Sec. 16-325-18: Display of seating capacity.

As a result of the alleged violations, you are subject to a telephone citation hearing pursuant to CGS 13b-103, and you are subject to a penalty pursuant to CGS 13b-108 in accordance with CGS 4-182. You are hereby directed to appear at a telephone citation hearing on September 14, 2023, at 10:00 AM for a Show Cause hearing as to why this Certificate should not be revoked, suspended, and/or imposed a civil penalty for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.
